# **TCOM Update**

### The Technical Committee (TCOM) update.

TCOM has continued working on the main objectives outlined in March, with a particular focus on the BMP write ups. We have also confirmed our strategic objectives and our alignment with the overall SWEMA strategic plan.



In terms of specific activities, the four complete BMP write ups have been distributed for review and comment. We are working on setting up a sub-committee to

look at producing another white paper. We are working on a trash removal testing protocol to propose to the state of California. They have a trash TMDL but no requirement for proving performance claims. We are working on a simple test based on the old Caltrans testing so it should be palatable for the state and easy for the industry.

We are also looking at ways to work more closely with GARC. For example, they can help us with the state of California; we can help them evaluate other state requirements.

As of this update I am tidying up the membership list so if you have not contacted me in the last 6 months your name will be dropped. Just e-mail me to get back on. Of course, we are also looking for new recruits. Anyone that is interested can contact me.

# **GARC Update**

### The Government Affairs and Regulatory Committee (GARC) update.

The Government and Regulatory Affairs Committee (GARC) has reestablished a core group of members to advance SWEMA positions on regulatory issues governing stormwater. Current members of the committee include Derek Berg of Contech, Brian Rustia of ADS, Dave Scott of Hydro International, Will Harris of BioClean a Forterra Company, and Ed Cristobal of StormTrap. Jay Holtz of Oldcastle is serving as Committee Chair.



In May, GARC prepared a letter to the US Environmental Protection Agency

(EPA) supporting the maintenance and advancement of national stormwater regulations as well as the continued funding of the EPA. The letter stresses the importance of national regulations in protecting water quality and reminds the Federal Government that environmental regulations foster innovation in a field that provides advanced degree and living-wage jobs. Support for a national BMP testing program was also mentioned.

Most recently, comments regarding BMP performance credits and sizing were prepared and submitted to the Virginia Department of Environmental Quality (VADEQ). Topics addressed include providing a method to convert treatment volume to peak flow, the importance of hydraulic loading rates, current limitations in the approach for assigning percent total phosphorus (TP) removal, inconsistencies in approval criteria, the importance of TP load reduction, and the need to establish permanent guidance.

Although there is nothing significant to report with regard to the Water Environment Federation's (WEF) National Stormwater Testing and Evaluation for Products and Practices (STEPP) initiative and the Interstate Technology and Regulatory Council's (ITRC) effort to create a stormwater guidance manual and BMP selection tool, GARC will continue to monitor these programs.

# Only in Canada, eh?

The Ontario Ministry of Environment and Climate Change is currently rolling out an Innovative Technology Verification (ITV) pilot program. Their goal is to adopt the requirements of the ISO14034 standard "Environmental Management – Environmental technology Verification". This would make Ontario the first jurisdiction to adopt a market driven ISO based ETV process as opposed to a government supported ETV program.

The focus of the Ontario program is on wastewater technologies but MOECC has been persuaded to look at stormwater technologies as well. In their opinion Oil Grit Separators are so well established in Ontario that they do not count as innovative and thus they are not eligible but filters are eligible. The strength, and weakness, of ISO14034 is that it does not specify a protocol. The downside is that it does not guarantee that all participants will produce the same data, so there may not be apples to apples. The upside is that it allows for different technologies to get approved while guaranteeing a certain general format of reporting and a certain data quality. The key to the program is the use of ISO accredited labs and verifiers.

Of particular interest is the fact that it should be possible to submit NJDEP or Canadian ETV program data for verification without the need of further testing. Details are still being worked out and the acceptance of existing data is not confirmed yet but there is reason for optimism. Companies that get verified will receive an internationally recognized ISO14034 certification. Keep your eyes open for updates from SWEMA.
