The Technical Committee (TCOM) update.

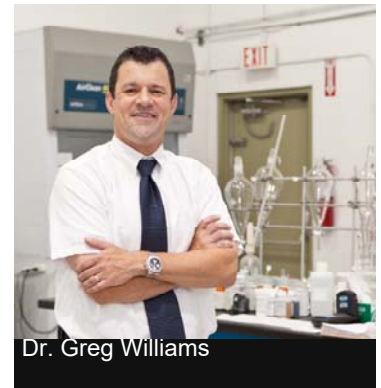
TCOMs has primarily been working on the trash testing protocol. It had now been handed off to GARC for presentation to the State of California in early May. The plan would be to work with the state to make changes to the protocol should they be required.

Having submitted a large number of suggestions for the Indianapolis protocol, it now looks like they will just adopt New Jersey. They may want to do something about floatables, in which case we have some options for them.

Participation has ticked up recently but so far no new initiatives have come to our attention. We will continue the monthly calls and keep our eyes open for things to do.

GARC Update

The Government Affairs and Regulatory Committee (GARC) update.

This late winter and early spring, the Government and Regulatory Affairs Committee (GARC) has continued to monitor evolving regulations affecting the application of Manufactured Treatment Devices (MTDs) nationally. Items currently requiring GARC input or being monitored by GARC include:

- ◆ STEPP – Development of a National BMP Testing Protocol
- ◆ ASTM Standards for Testing MTDs – Codification of national BMP testing protocols
- ◆ Indianapolis – Development of a new MTD testing protocol
- ◆ City of Alexandria – Exclusion of MTDs for stormwater treatment
- ◆ California Trash Capture – Draft Test Protocol Rollout
- ◆ California Mosquito Control – Potential effects on MTD design and other requirements
- ◆ ODOT Test Facility – MTD performance and maintenance testing
- ◆ Virginia Clearinghouse – Phosphorus reduction credits
- ◆ Great Lakes Stormwater Collaborative – Stormwater technology transfer
- ◆ Wisconsin Land and Water – Proprietary Filtration Device Technical Standards Team

Over the last three or four months, GARC has advanced a number of these issues. For example, GARC is participating in ongoing stakeholder meetings for WEF's STEPP program which is showing new energy and progress under Seth Brown's direction. GARC wrote a Regulatory Comment Letter to the City of Indianapolis asking the City to use an established MTD testing protocol rather than developing a new one of their own. The City ultimately agreed to adopt the NJDEP protocol, NJCAT verification, and NJDEP certification program. A Regulatory Comment Letter was sent to the City of Alexandria last fall, asking the City to accept MTDs as an alternative to non-proprietary stormwater treatment systems. Unfortunately, the City recently decided to continue to exclude MTDs as an option. The letters provided to the City of Indianapolis and the City of Alexandria are posted on the SWEMA website.

Finally, GARC members also helped review the SWEMA Technical Committee's draft test protocol for trash capture devices and are now prepared to introduce the document to California regulators and other stakeholders at the Trash Devices & Mosquito Control Meeting in South Lake Tahoe, California later this month. Getting to the May 17th Membership Meeting is Easy!
